**CASH:**

**Operating Cash** in the South State checking account totals is \$661,900.68. February payables not paid until March are \$8,227.06, Accrued payables are \$41,781.94, APM Transfer Fee \$150.00, ATT Rebate of \$95,499.95, Prepaid Maintenance Fees are \$80,485.33, the net operating cash is \$435,756.40.

**Refundable Lease Deposit Cash** in the South State banks is \$351,221.41.

**Year to date income for Fines** is (\$916.66).

**Total income revenue** (rental income, gate/key/app fees, late fees and interest by homeowners, other income) is \$13,987.45.

**Capital Contribution** to date is \$315,872.46.

**Reserve Cash** in the South State, Valley National, and Seaside accounts total \$1,968,079.38.

**Current year to date expenses are as follows:**

**Common**

**Year to date expenses** are \$294,263.03 Over budgeted items included Cap Expned-Special Proj., Electric, Night/day patrol, and Security Services. This overage is covered by additional income and maintenance fees of \$299,706.11, leaving a **SURPLUS** of \$5,443.08.

**Townhomes**

**Year to date expenses** are \$36,625.83 including reserve funding of \$15,833.34. There are no over budget items. YTD Townhome Maintenance fees are \$53,600.50 plus a Carry Over Surplus of \$2,127.16. This leaves a **SURPLUS** of \$19,101.83.

**Year to Date:** Combined Revenue (Common and Townhome) for the year to date is \$355,433.77, with year to date operating expenses of \$330,888.86 including the Reserve funding of \$46,666.68. The current year to date **SURPLUS** is \$24,544.91.

**Fund Balance:**

As of 1/1/2023, the Fund Balance **SURPLUS** is \$567,767.72. The current year to date **SURPLUS** month ending December is \$24,544.91. The current year **Carry Over Surplus for Common** is (\$19,054.16) and the **Carry Over Surplus for Townhomes** is (\$2,127.16). The current Transfer to Reserves is (\$250,000.00). The total Fund balance year to date is a **SURPLUS** of \$321,131.31.

**Accounts Receivable:**
