**CASH:**

**Operating Cash** in the South State checking account totals is \$895,266.31. March payables not paid until April are \$114,351.40, Accrued payables are \$33,388.82, APM Transfer Fee \$150, ATT Rebate of \$109,824.98, Prepaid Maintenance Fees are \$93,248.53, the net operating cash is \$548,302.58.

**Refundable Lease Deposit Cash** in the South State banks is \$386,543.78.

**Year to date income for Fines** is \$7,495.80.

**Total income revenue** (rental income, gate/key/app fees, late fees and interest by homeowners, other income) is \$4,160.95.

**Capital Contribution** to date is \$287,092.26, \$3,381.21 for the townhomes.

**Reserve Cash** in the South State, Valley National, and Seaside accounts total \$1,471,036.65.

**Current year to date expenses are as follows:**

**Common**

**Year to date expenses** are \$327,893.03. Over budgeted items included general and pool maintenance and security services. This overage is covered by additional income and maintenance fees of \$368,382.66, leaving a **SURPLUS** of \$40,489.63.

**Townhomes**

**Year to date expenses** are \$43,183.26 plus reserve funding of \$23,750.01. The over budget items include irrigation, pest control, and irrigation pump. YTD Townhome Maintenance fees are \$89,055.00. This leaves a surplus of \$22,121.73. The Townhomes have a prior year surplus of \$8,649.72. The net Townhomes Fund Balance is a **Surplus** is \$30,771.45.

**Year to Date:** Combined Revenue (Common and Townhome) for the year to date is \$489,761.46, with year to date operating expenses of \$371,076.29 and the Reserve funding of \$67,500.00. The current year to date **SURPLUS** is \$51,185.17.

**Fund Balance:**

As of 1/1/2022, the Fund Balance **SURPLUS** is \$332,487.05. The current year to date **SURPLUS** month ending March is \$51,185.17. The total Fund balance year to date is a **SURPLUS** of \$383,672.22.

**Accounts Receivable:**

As of 03/31/22, there is \$211,894.35 in arrears.
