TREASURERS REPORT FOR PERIOD ENDING MAY 31, 2022

CASH:

Operating Cash in the South State checking account totals is \$847,020.43. May payables not paid until June are \$45,049.93, Accrued payables are \$37,424.53, APM Transfer Fee \$150, ATT Rebate of \$106,641.64, Prepaid Maintenance Fees are \$93,919.90, the net operating cash is \$563,834.43.

Refundable Lease Deposit Cash in the South State banks is \$386,543.78.

Year to date income for Fines is \$20,062.46.

Total income revenue (rental income, gate/key/app fees, late fees and interest by homeowners, other income) is \$31,697.69.

Capital Contribution to date is \$290,687.44, \$3,381.21 for the townhomes.

Reserve Cash in the South State, Valley National, and Seaside accounts total \$1,519,352.30.

Current year to date expenses are as follows:

Common

Year to date expenses are \$631,892.83. Over budgeted items included general and pool maintenance and security services. This overage is covered by additional income and maintenance fees of \$673,621.64, leaving a **SURPLUS** of \$41,728.81.

Townhomes

Year to date expenses are \$68,312.26 plus reserve funding of \$39,583.35. The over budget items include irrigation, pest control, and irrigation pump. YTD Townhome Maintenance fees are \$148,425.00. This leaves a surplus of \$40,529.39.

Year to Date: Combined Revenue (Common and Townhome) for the year to date is \$821,925.27, with year to date operating expenses of \$627,288.44 and the Reserve funding of \$112,500.00. The current year to date **SURPLUS** is \$82,258.20.

Fund Balance:

As of 1/1/2022, the Fund Balance **SURPLUS** is \$332,487.05. The current year to date **SURPLUS** month ending May is \$82,258.20. The total Fund balance year to date is a **SURPLUS** of \$414,745.25.

Accounts Receivable:

As of 05/31/22, there is \$221,022.13 in arrears.
