III. Ratify Holiday Lighting: Michele Lee Longerbeam discusses the approved motion made via email on 8/23/2022 to accept Randy's Holiday Lighting as the vendor for the holiday lights. She explains the previous contract with Elite Christmas Lighting came to term, so management and board members researched and visited a few Associations to see the results of other holiday companies' work. There were three bids submitted for review.

Michele Lee Longerbeam made motion, 2nd by Joe Passarelli to accept the bid by Randy's Holiday Lighting as official record into the minutes. All in favor. The motion carried.

IV. Vending Machines: Michele Lee Longerbeam explains the Association has been approached by several vending machine companies interested in putting snack and beverage machines by the pool areas and allowing the Association another source of revenue. Further discussion ensued on owning machines outright versus using a vending company. Michael Rivera made motion, 2nd by Michele Lee Longerbeam to explore different vending machine companies and options. Michele Lee

Longerbeam, Michael Rivera, and Michael Joie voted to approve the motion with Joseph Passarelli denying. The motion carried.

Old Business:

- I. Amenities: Michele Lee Longerbeam updates the residents with the basketball/pickleball/shuffleboard project. She states Sports Surfaces is waiting on permit approval for the fencing and lighting. The expected start of the project is mid-November.
 - Michele Lee Longerbeam asks property manager, John Kiechle to discuss the townhome irrigation. John Kiechle speaks regarding the problems that have recently occurred with the pumps and the reasons for the irrigation being shut off. He explains he has scheduled three companies to come inspect the pumps, provide the life expectancy, and also quote new pumps.
- II. Clubhouse: Michele Lee Longerbeam brings up the bids that were submitted at the last Board Meeting for impact windows and the pricing not being cost effective. She discusses the motion at the last meeting for Management to obtain bids for roll down/accordion shutters. Three bids were submitted to the Board of Directors for review. Joe Passarelli requests pictures of the roll down shutters and accordion shutters before making any motion. He asks management to provide photos at the next Board of Directors meeting.
- III. Townhome Trees: Michele Lee Longerbeam discusses the approved motion made in September 2021 to remove hardwood trees in the townhome common areas and in front of the townhome lawns that were not removed in the past. The trees are lifting the pavers and sidewalks and disrupting piping underground. She explains three bids were submitted for review. Discussion ensued on the bids. Joe Passarelli made motion, 2nd by Michael Rivera to accept Green Lawn Svc & Sod Installation, Inc.'s bid for tree removal. All in favor. The motion carried.
- IV. Maintenance Building: Michele Lee Longerbeam speaks regarding the Portofino Isles CDD Board of Directors no longer wanting to partner with Newport Isles POA on the maintenance building. Michele Lee Longerbeam made motion, 2nd by Michael Rivera for the HOA to pursue the maintenance building on their own. All in favor. The motion carried.

V. Events: Michele Lee Longerbeam announces the upcoming scheduled events at Newport Isles. This includes:

Owners Forum:

<u>Adjournment:</u> With no further business to discuss, Michele Lee Longerbeam made a motion, 2nd by Michael Rivera to adjourn the meeting at 7:49PM. All in favor. The motion carried.
